The Bee Grant Program and Renewal Grant Program seek to stimulate in young people a curiosity about the importance of bees in our lives and food system, the need to understand and embrace them, and the value of caring about their well-being.

The Renewal Bee Grant is offered by the Whole Kids Foundation in partnership with The Bee Cause Project. The Renewal Grant may be awarded to a school or non-profit organization that has previously received a Bee Grant through this program, been a recipient in 2020 or earlier, and has submitted their progress report and annual bee grant survey. While our main goal is to support live bee program education, we understand that may not always be possible. The Renewal Grant exists to grow pollinator programming with or without live bees.

## Grant Details

All Renewal Grants are valued at \$1,000 per grant and include:

- **Monetary Grant of \$500 written to the grantee organization.**
- **Technical Support, Program Development and Remote Consultation** from The Bee Cause Project.
- **Educator Resource Pack (Digital Version)**: The Educator Resource Pack is designed to guide and support Bee Grant educators through the development and growth of pollinator programming. The activities, lessons, and guides in this educator pack are designed to meet you where you are in your bee programming, whether that is in the classroom, outdoors, or distance learning.
  - Educator Guides for implementing and developing pollinator programming.
  - Core compliant lesson plans and activities equipped for classroom and/or distance learning initiatives.
  - Grow Your Bee Program! Native Bee Learning Supplements for holistic pollinator perspectives.
  - Planning tools to prepare your campus and community for native bees, pollinators, and if welcome, live honey bees.

### **ELIGIBILITY:**

1. Applicants must have received a Whole Kids Foundation + The Bee Cause Project “Bee Grant” in 2020 or earlier and have submitted their progress report and any annual bee grant surveys.
2. Funds and materials must be dedicated to support pollinator programming for students.
3. The principal or executive director must be aware of and supportive of the pollinator programs.

4. There must be an individual at the school or organization who is the designated “Bee Advocate.” This role serves as the point of contact for pollinator programming.

Applications will be reviewed once the application window has closed on **October 15th, 2021**. All applicants who submitted an application will be **notified no later than December 8<sup>th</sup>, 2021**. Grant packages will be **received February 2022**.
