

## THE WHOLE KIDS YOUNG ENTREPRENEURS SWEEPSTAKES OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

**SWEEPSTAKES ENTRY PERIOD:** The Whole Kids Young Entrepreneurs Sweepstakes (the "Sweepstakes") begins at 12:00:01 AM Central Time ("CT") on Wednesday, March 18, 2020 and ends at 11:59:59 PM CT on Wednesday, April 15, 2020 (the "Sweepstakes Period").

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, and Canada (excluding Quebec) who are age 18 or older at the time of entry and are the parent/legal guardian of a child between the ages of 11-18 years old who is a participant in a young entrepreneur business or school entrepreneurial program at the time of entry (each, a "Child") or a teacher of an eligible Child(ren) with express permission from the Child(ren)'s parent/legal guardian to submit an Entry featuring his/her Child(ren) into the Sweepstakes (each, an "Entrant"). Sponsor may require any Entrant that is a teacher to have a Photograph and Video Release Form completed and signed by each Child's parent/legal guardian whose Child(ren) will appear in an Entry. Noncompliance may result in such Entrant and any/all associated Entries being disqualified. Void in Puerto Rico, Guam, the U.S. Virgin Islands, Quebec, outside the U.S./Canada, and wherever else prohibited by law. Employees of Whole Kids Foundation (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. **HOW TO ENTER:** To participate, Entrant must create a video not to exceed 3 minutes in length featuring their Child and must include the Child's first name, age, school, grade, city and state/province and show the Child describing how their business or program is helping to change the way kids eat through gardening, plant-forward cooking or healthy eating, tips for success, and their biggest lesson(s) learned from the business or program (the "Video"). If Entrant is a teacher, they may include multiple Children in the Video and must include the Entrant's first name, classroom, school, grade, city and state/province instead of the information for the Child(ren) in the Video. There are five (5) ways to submit an entry:

join the group and once approved as a member by the group administrator upload a Video to the group page to receive one (1) entry into the Sweepstakes (the “Facebook Entry”). By submitting a Facebook Entry, entrants agree to [Facebook’s Terms of Service](#). **This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook, Inc.**

**Method #3: YouTube Entry.** During the Sweepstakes Period, Entrant must log in to his/her public YouTube account, upload a Video to his/her public account and include “#WholeKidsBiz Sweepstakes” in the Video title to receive one (1) entry into the Sweepstakes (the “YouTube Entry”). Sponsor will add eligible YouTube Entries to the #WholeKidsBiz Sweepstakes Playlist at [https://www.youtube.com/playlist?list=PLkXAEYJtK76qJu--l\\_5XpdXC4fvWfJilz](https://www.youtube.com/playlist?list=PLkXAEYJtK76qJu--l_5XpdXC4fvWfJilz). **Method #4: Instagram Entry:** During the Sweepstakes Period, Entrant must log in to his/her public Instagram account, upload and share a Video to his/her public Instagram account including the hashtags #WholeKidsBiz and #Sweepstakes and @wholekidsfoundation in the post caption to receive one (1) entry into the Sweepstakes (the “Instagram Entry”). By using the hashtags, participant indicates his/her agreement to these Official Rules. Entrant’s Instagram settings must be public. Entries uploaded from “private” Instagram accounts will not be eligible. By submitting an Instagram Entry, entrants agree to [Instagram’s Terms of Use](#). **This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Instagram or Facebook, Inc. **Method #5: Twitter Entry:** During the Sweepstakes Period, participants must log in to his/her public Twitter account, follow @wholekidsfnd on Twitter at <https://twitter.com/wholekidsfnd>, post a Tweet that includes a Video and the hashtags #WholeKidsBiz and #Sweepstakes to receive one (1) entry into the Sweepstakes (the “Twitter Entry”). If a Tweet is more than one post in length it will be considered as one (1) entry into the Sweepstakes with the first post considered the Twitter Entry. By using the hashtags, participant indicates his/her agreement to these Official Rules. Entrant’s Twitter settings must be public. Tweets from private Twitter accounts will not be eligible. Twitter Entry must be posted directly from a participant’s Twitter account. The decisions of the Sponsor are final and binding on all matters relating to determine eligibility of Tweets. Entrants must follow and continue to follow @wholekidsfnd through at least May 17, 2020 in order to be notified in the event he/she is a potential winner. **IMPORTANT: MESSAGE AND DATA RATES MAY APPLY TO USE OF MOBILE PHONE/DEVICE TO PARTICIPATE IN SWEEPSTAKES.**

Online Entry, Facebook Entry, YouTube Entry, Instagram Entry and Twitter Entry collectively referred to herein as “Entry” or “Entries”. **Limit: One (1) Entry per Entrant regardless of method of Entry.** All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned. The Sponsor will review all submitted Entries prior to such Entries being published and reserves the right in its sole and absolute discretion to reject, disqualify and/or remove any Entry that violates these Official Rules without any notification or warning. Posting by the Sponsor does not indicate the Entry has complied with the Official Rules. Sponsor reserves the right to post sample Videos it has created in connection with the Sweepstakes the Sponsor's websites and social sites. Sponsor does not guarantee the posting of any Entry.

- Videos must conform to the format and size requirements and limitations of the Sweepstakes Website, Facebook, YouTube, Twitter or Instagram.

- Entry and Video cannot reference or contain materials embodying copyrighted images, names, likenesses or other indicia identifying any brand, products, company or person, living or dead, without permission.

- Entry and Video cannot communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor, Twitter and Instagram wish to associate.
- Entry and Video cannot depict illegal activity and cannot itself be in violation of any law.
- Entry and Video cannot in any way reference persons or organizations without written permission from any person or organization whose name or likeness is used.
- Entry and Video may not include images of a known celebrity, famous or well-known person or any image which violates the right of privacy or publicity of any person.

**PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:**

**Grand Prize:** There is one (1) Grand Prize available to be won. Grand Prize includes \$1,000 awarded in the form of a check. **The ARV of Grand Prize: \$1,000 USD/\$1,342.71 CAD.**

**First Prizes:** There are five (5) First Prizes available to be won. Each First Prize includes \$500 awarded in the form of a check. **The ARV of the First Prize: \$500 USD/\$671.36 CAD each.**

**Second Prizes:** There are six (6) Second Prizes available to be won. Second Prize includes \$250 awarded in form of a check. **The ARV of the Second Prize: \$250 USD/\$335.55 CAD each.**

**RANDOM DRAWING:** The winners will be selected in a random drawing on or about **Friday, April 17, 2020** from among all eligible entries received during the Sweepstakes Period by the Sponsor whose decisions are final.

**WINNER NOTIFICATION & VERIFICATION:** If the Entrant that submitted the potential winning Entry entered via an Online Entry, he/she will be notified via email and/or phone, and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver and, where allowable, a Publicity Release (collectively, "the Releases") or, if winner is a Canadian resident, a Declaration and Release Form (the "Declaration"). If Grand Prize winner is a US resident, the Releases will require the Grand Prize winner to furnish his/her Social Security Number for the sole purpose of tax reporting, as required by law. If the Entrant that submitted the potential winning Entry entered via an Facebook, YouTube, Instagram or Twitter Entry, he/she will be notified by Sponsor's account on the corresponding platform via direct message and/or comment to his/her public account used to submit the Entry (the "Initial Notification"). To begin the prize claim process, a potential winner must respond as instructed to the Notification with his/her full name and email address within 48 hours of the Initial Notification. Within two (2) business days of confirmation of the information received from a potential winner in response to Initial Notification, such potential winner will receive a second notification (the "Second Notification") via email from the Sponsor and will be required to sign and return, within seven (7) days of the Second Notification, the Releases. Any potential prize winner who does not reply to any notification with the required information and within the specified time period will be disqualified and an alternate winner may be selected in a separate random drawing.

If any winner is a Canadian resident, then he/she will be required to correctly answer a skill-based mathematical test question without mechanical or other aid (which may, in the sole and absolute discretion of the Sponsor, be administered online, by email or other electronic means, by telephone, or in the Declaration) within a limited time-period in order to be eligible to receive his or her prize. Not providing the answer within the required time period, providing an incorrect or incomplete answer, or noncompliance with the terms of administration of the skill-testing question will result in disqualification of the potential winner and an alternate winner may be selected. Without limiting the generality of the forgoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.

Noncompliance will result in disqualification and an alternate winner may be selected. Prizes will be awarded within approximately 30 days after the winner is verified.

If a prize notification or prize is returned as undeliverable or if winner is found to be ineligible or not in compliance with these rules that winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing.

**PRIZE CONDITIONS:** Prizes are not redeemable for cash. Prizes are not assignable nor transferable. No substitution is permitted except if prize is unavailable, in which case a prize of equal or greater value will be awarded. **GOVERNING LAW AND LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

**DISPUTES:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Travis County, Texas and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date

within fourteen (14) days of the filing of a “Demand for Arbitration”, then either party can elect to have the arbitration administered by the American Arbitration Association (“AAA”) or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Austin, TX. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn’t apply and the dispute must be brought in a court of competent jurisdiction in Austin, TX. Sponsor agrees to pay the administrative and arbitrator’s fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

**PRIVACY:** As a condition of entering the Sweepstakes, each entrant gives consent for Sponsor to obtain and deliver his or her name, address and other information to third parties, including Sweepstakes Administrator, for the purpose of administering this Sweepstakes and to comply with applicable laws, regulations and rules, including, without limitation, the storing of your personal information for purposes of complying with state record retention requirements.
